## Property tax payment deadline is Wednesday, Jan. 31

AUSTIN – Property owners have until Jan. 31, 2024, to pay their property tax bills without state-mandated penalty and interest charges.

Travis County Tax Assessor-Collector Bruce Elfant encourages property owners to pay their property taxes online to avoid late payments and the risk of mail theft.

"The safest and most convenient way to pay is by eCheck for \$1 at <a href="TravisCountyTax.org">TravisCountyTax.org</a>," Elfant said. "It's only a few cents more than a postage stamp. You'll receive immediate proof of payment and avoid any worry about your check being lost or stolen."

For those who must mail a check, Elfant recommends delivering it inside the post office to a postal clerk and requesting a hand cancellation to ensure it's postmarked no later than Jan. 31, 2024.

Property owners who cannot pay in full and want to set up a payment plan can review their payment options and apply online at the tax office website, <a href="mailto:TravisCountyTax.org">TravisCountyTax.org</a>. Owners with a senior, disabled or disabled veteran homestead exemption can sign up to pay taxes in four installments without penalty and interest charges.

Travis County homeowners may notice a significantly lower tax bill this year thanks to the increased homestead exemption for school taxes approved by the Texas Legislature and voters. The average tax bill for property owners with a homestead exemption decreased by \$658. Homeowners with a senior or disability exemption received even greater reductions, averaging \$1,351.

Property owners who escrow their taxes through a mortgage company will have their taxes paid automatically and may not see these savings until their next annual escrow analysis. However, they can visit TravisCountyTax.org to view their 2023 tax bill and confirm if the mortgage company paid in full.

The **Travis County Tax Office** annually collects \$5.8 billion in local property taxes for 153 local government entities and \$1.6 million in court fees on behalf of the County Courts, District Courts and Justices of the Peace. The office registers and titles almost 1 million vehicles, registers over 850,000 voters, and supports elections for 201 local government entities. The Tax Office operates six locations in Travis County and many services are available online.
